Kharkiv Resilience Fund (KRF): A sub-fund focused on Ukraine's second-largest city, Kharkiv - a frontline community enduring continuous bombardment. This program supports a range of targeted initiatives, from providing science kits and online learning tools to children, to procuring specialty materials such as fabrics for manufacturing vests used by first responders. In accordance with donor specifications, KRF may retain and carry forward restricted balances to ensure continuity and flexibility in mission-aligned project execution.

To maximize operational efficiency and impact, the Ukrainian Refugee Foundation (URF) partners with select nonprofit organizations in the EU and Ukraine that share its humanitarian mission. These organizations are often better positioned to carry out certain activities locally. URF enters into Memoranda of Cooperation with each partner, allowing for the transfer of unrestricted funds when appropriate. Unless specified otherwise, such transfers may be used by the partner for general charitable purposes, provided their activities remain consistent with URF's 501(c)(3) status and the terms of the Memorandum.
